THE YOUTH EMERGENCY SHELTER IS A 24-HOUR SAFE HAVEN FOR YOUTH IN CRISIS, AGES 10-17, WHERE THEY CAN SLEEP IN A STABLE ENVIRONMENT, EAT THREE NUTRITIOUS MEALS A DAY, OBTAIN CLOTHING, RECEIVE COUNSELING, SUPPORT AND ACCESS TO A FULL RANGE OF SERVICES. THE SHELTER SERVED 142 YOUTH, PROVIDED 2,537 NIGHTS OF SHELTER, AND PROVIDED 2,741 CASE MANAGEMENT AND LIFE SKILLS EDUCATION HOURS.
