SWOP HAD A GREAT YEAR IN 2015-2016, ACHIEVING VICTORIES IN NEW CAMPAIGNS AND AGE-OLD ISSUES, LEVERAGING THE POWER OF DEEP, LONG-TERM ORGANIZING ON LOCAL AND NATIONAL LEVELS TO HAVE AN IMPACT ON URGENT POLITICAL MOMENTS WHEN COMMUNITY IS THREATENED. DEFENDING AGAINST MALICIOUS POLITICAL ENTITIES, HOLDING OFFICIALS ACCOUNTABLE, AND PUSHING POLICIES AND PROGRAMS ACROSS THE FINISH LINE. LAST YEAR, WE SET OUT TO TACKLE LARGE ISSUES WHERE LOCAL COMMUNITY WAS DISENFRANCHISED, MARGINALIZED, AND CHARACTERIZED AS THE VERY PROBLEMS THEY SOUGHT TO ADDRESS.
