Early Intervention services are provided to any family in Maricopa County who has a child (from birth to three years) with a documented vision impairment. Teachers of the Visually Impaired provide the family with technical, emotional and informational support through home visits, in collaboration with other Early Intervention providers. Early Intervention Vision Specialists support the family from initial diagnosis through a transition to school based services. They address individualized family priorities with strategies, adaptive tools and expertise for how the specific vision impairment impacts that child's access to and engagement throughout family routines. Itinerant vision teachers travel throughout Maricopa County teaching students in their home school districts, charter and private schools. Our goals is to teach children, without vision, compensatory skills that facilitate the same access to information as their sighted peers, make progress in their educational curriculum and have meaningful interactions with others. The Youth & Family Service Department offers resources for families such as support, information, and guidance to families who have a person with a visual impairment. They also offer crisis and adjustment counseling, weekly support groups, adaptive recreation (SHARP), monthly family events and independent living skills training (Teen to Work). Last year we served 187 families, 71 children in SHARP and 12 students in Teen to Work.
