Throughout fiscal year 2016, PAI provided full-service grounds maintenance, landscaping and cemetery maintenance for the United States Army at Fort Huachuca, and a full range of custodial services to the Department of Homeland Security at the Brian A. Terry Border Patrol Station in Naco, Arizona. Giving preference to people with disabilities, more than 75% of our employees have a significant disability. We provide development and access to jobs for a segment of our community that traditionally bears a 70% unemployment rate. These jobs allow us to provide health care coverage, profit sharing, and a 401(k) plan. During fiscal year 2016, we also provided residential group home, habilitation and day treatment programs for individuals with severe disabilities. Throughout the year we provided services to more than thirty disabled individuals.
