The Arizona Statewide Gleaning Program (which in the future will be referred to as the Transportation Program) distributed 28,194,972 pounds of food AAFBs two drivers transported 826 total loads AAFB also supported purchasing food through several programs resulting in a total benefit of \$244,599.38 and 1,657,808 pounds Purchases with state funds and donations were conducted by AAFB primarily to provide food banks with produce during non-growing seasons AAFB also supported the Arizona food bank network by providing technical assistance and capacity building This included help writing and reviewing policies/procedures, developing inventory tracking processes, and providing resources for various regulations and processes This support was provided to both member food banks as well as agency partners as needed throughout the year

Food Bank Coordination AAFB works daily with all members of the network to plan transportation and develop a statewide sourcing strategy AAFB coordinates activities with a variety of stakeholders, including the Arizona Department of Agriculture, Arizona Department of Economic Security, other non profits and agency partners and the public to ensure food safety standards and network response to emergency food needs AAFB also offers training and networking opportunities to increase public education, further food bank operations and increase collaboration

Children and Youth Programs AAFB worked with community partners to promote greater access to school meals and summer feeding programs As of September 2016, 38 school districts had newly elected to provide meals for all children in their district for the 2016-2017 school year, AAFB staff contacted 25 of these directly AAFB partnered with the Arizona Community Action Association to plan SNAP outreach for an additional 218 low income school districts AAFB promoted school breakfast expansion and worked with the Arizona School Breakfast Coalition in Maricopa County
