Emergency Assistance Since 1985, Interfaith Community Services (ICS) has provided financial assistance, short-term case management, and other support for individuals or families in emergency situations. The goal is to provide for acute basic needs that help clients in distress get back on their feet and take steps toward stability and independence. The types of assistance include rent, utilities, emergency prescriptions, food and gas vouchers, and back-to-work items such as permits, ID's and clothing vouchers. During 2015-2016, ICS served 7,032 individuals providing \$763,782 in financial assistance, a 9% increase over the prior year. ICS partners with the Community Food Bank of Southern Arizona to distribute emergency food boxes to low-income seniors, individuals and families in need. During 2015-2016, ICS distributed \$1.9 million worth of food to hungry individuals and families.

Senior & Caregiving Services Since 1985, Interfaith Community Services (ICS) has provided services which help seniors and disabled individuals to live independently in their own homes, without the need for institutional care. Volunteers provide services such as fresh nutritious meals, transportation for medical appointments and shopping, reassurance calls, friendly phoning, friendly visiting, small home repairs, and business help. During 2015-2016, ICS provided 10,437 services to 1,356 seniors and disabled. The Mobile Meals program provides delivery of fresh nutritious meals each weekday to elderly, physically challenged or convalescing adults who are unable to cook for themselves. Mobile Meals are provided on a sliding-scale-fee basis based on ability to pay. More than 60% of Mobile Meals recipients receive fully or partially subsidized meals. ICS served 16,872 meals during the year.

Faith & Community Health Network Since 1985, Interfaith Community Services (ICS) has brought together health facilities, faith communities, and social services to enable individuals to lead healthier lives and help vulnerable individuals in our community stay healthy at home. The program includes training workshops, health advocacy programs, and our newest Care Partners program. Health Advocacy and Care Partners are new and unique programs that help vulnerable individuals in our community with non-medical support services to avoid financial and emotional costs of unnecessary hospital re-admission and help them better navigate available community resources to help maintain their independence.
