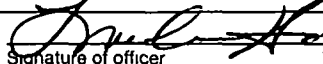

SCHN provides medical coverage for the Acute members eligible under Title XIX Medicaid program and Title XXI program, institutional care and home and community based services for the Long Term Care members, and medical coverage for the eligible members of the Division of Developmentally Disabled. SCHN operates a Medicare Advantage Plan under the Centers for Medicare and Medicaid Services (CMS), offering medical and prescription drug benefits to qualified members. It is operated as a Special Needs Plan for members who are eligible for both Medicare and Medicaid coverage.

Benefits vest under this 457(f) plan at the later of the date the participant attains age 62 or is credited with 15 years of service. The 2010 Executive Deferred Compensation Plan is for certain officers and key employees, primarily those who are not eligible to participate in the Dignity Health Excess Benefit Plan or the 2007 Executive Deferred Compensation Plan described above. This benefit provides an annual accrual of 10% of total compensation and is payable annually on July 1 once vested, which is age 62 with 5 years of service; the plan also allows for special awards. Payment pursuant to the plan arrangement for one director occurred during 2015: L. Hunt, \$129,468. **Part I, 4b** - Certain directors participate in the Dignity Health Excess Benefit Plan, a nonqualified supplemental benefit plan limited to participants in the Dignity Health Retirement Plan whose benefits are affected by the limitations imposed by sections 401(a)(17) and 415 of the Internal Revenue Code. Benefit service under this plan was frozen as of January 1, 2008. There were no payments related to this plan in 2015.

Part I, 4b - Certain listed persons participate in the Dignity Health Key Employee Share Option Plan (KeySOP), which was frozen in May 2002. The KeySOP program was established in 2001 with the purpose of providing income deferral opportunities to employees eligible for the company's key employee retention program. No payments were made under this plan during 2015.
