ARM HAS DEVELOPED 146 UNITS OF AFFORDABLE HOUSING FOR THE PURPOSE OF PROVIDING HOUSING AT BELOW FAIR MARKET RENT TO FORMERLY HOMELESS AND LOW INCOME HOUSEHOLDS TO HELP THEM STABILIZE AND MAINTAIN THEIR SELF- SUFFICIENCY. ARM HELPS LOW INCOME RENTERS BY DEVELOPING AND MANAGING AFFORDABLE HOUSING UNITS THAT ARE URGENTLY NEEDED IN OUR COMMUNITY. ARM PROVIDES A VITAL LINK IN THE CONTINUUM OF SERVICES TO ALLOW FORMERLY HOMELESS HOUSEHOLDS TO MOVE FROM INSTABILITY TO MORE PERMANENT HOUSING. FAMILIES IN THE ARM PROGRAM CAN ACCESS SUPPORTIVE SERVICES TO HELP THEM STABILIZE FINANCIALLY AND MAINTAIN THEIR SELF-SUFFICIENCY. DURING FY 15- 16, ARM SERVED 164 HOUSEHOLDS CONSISTING OF 568 ADULTS AND CHILDREN. 64% OF HOUSEHOLDS SERVED DURING FY 15-16 CAME FROM THE CITY OF MESA. 20% OF FAMILIES EARNED BELOW 30% OF AREA MEDIAN INCOME (AMI), 72% EARNED BELOW 50% OF AMI AND 28% EARNED BELOW 80% OF AMI. 77% OF ARM FAMILIES PARTICIPATED IN SUPPORTIVE SERVICES WITH ARM'S AFFILIATE SAVE THE FAMILY THROUGH THEIR FAMILIES, ADULTS, AND CHILDREN'S EMPOWERMENT SERVICES-FACES. ARM CONTINUES IN ITS FIFTH YEAR OF OPERATING THE SHELTER PLUS CARE COLLABORATION WITH THE CITY OF MESA AND MERCY MARICOPA INTEGRATED CARE (MMIC) PROVIDING 12 UNITS OF PERMANENT SUPPORTIVE HOUSING FOR FAMILIES WHO ARE CHRONICALLY HOMELESS WITH A DISABILITY OR WHO HAVE BEEN DIAGNOSED WITH SEVERE MENTAL ILLNESS.
