Victim Advocates will provide immediate crisis intervention and will be available to help victims obtain Orders of Protections, provide court escort, and to explain the criminal justice process. Professionals located at Amberly's Place are able to assist with accessing other community resources for emergency food, clothing and housing. Complete wrap-around services are offered. By locating those involved in the investigation and treatment of child abuse, domestic violence, sexual assault and elder abuse under one roof, the team members will be able to accomplish in hours what ordinarily takes several weeks.
