Community Action Food Bank alleviates hunger by providing food/basic needs packages, counseling, budgeting and referrals to other community services. The program provided 16,780 food and basic needs packages to 12,278 people. The food bank also provided food to 40 community partner organizations for distributions to their low-income clients. The total pounds of food distributed was almost 5 million pounds. The food bank operates several of its own food pantries as well as four community gardens. The expense includes the value of the donated food from community food drives, grocers, food industry, farmers, and USDA commodities. Our Kids Nutrition Packs Program served 1,200 children in 12 low-income schools.

The Circles Initiative works to help families move out of generational poverty through training and matching them with highly trained community volunteers from the middle class. The participating families receive special training to help them overcome the barriers to moving out of poverty. The Initiative also identifies and works on systemic barriers that keep people in poverty. In FY 2016 the program worked with 67 families. Three families moved out of poverty and eight participants are attending college. 63% of the families reduced debt, 38% increased savings, and 79% have increased income. In addition, ARRIVE Utah has assisted two new communities in Utah in planning for their own Circles Initiative.

The Family Development and Support Services Program provided a variety of direct services to help eligible households stabilize and work toward self-reliance. These services include emergency shelter and/or rent help (760 households), transportation assistance (430), help with identification and birth certificates (241 persons), case management, life skill training, goal setting, and more.
