Adult Community Conferencing-RJCA creates a forum in which people impacted by crime meet with offenders who commit the crimes to discuss the impact and determine restitution. It is through these community forums that RJCA achieves its primary objectives of effectively addressing misdemeanor and low level felonies which helps prevent further crime and community deterioration while repairing the harm caused by criminal behavior. RJCA also provides opportunities for community-building by creating relationships within neighborhoods allowing people to work together to reinforce norms of acceptable behavior. As referred participants (offenders) recognize the impact of their behavior, they receive support and often times connect with the community in positive ways. In FY16, 317 adult offenders enrolled in RJCA, 291 cases were conferenced (93% attendance rate), and 284 successfully completed the program out of 291 conferenced cases (96% success rate). Referred participants completed 1,825 hours of community service, gave 158 apologies, and donated \$2,140 in the communities that were affected. They also completed 186 personal development activities such as working on education (GED) or writing reflection essays. This year, 233 community member participations and 97 trained volunteer facilitations occurred by 100 volunteers who met face-to-face with the 291 conferenced cases.

Youth Community Conferencing--RJCA creates a forum in which people impacted by crimes meet with offenders who commit the crimes to discuss the impact and determine restitution. In FY16, 111 youth offenders enrolled in RJCA, 105 cases were conferenced (95% attendance rate), and 92 successfully completed the program out of 105 conferenced cases (88% success rate). Referred participants completed 553 hours of community service and gave 89 apologies in the communities that were affected. They also completed over 200 hours of personal development activities such as working with a tutor, creating a graduation plan, attending anger management classes or writing reflection essays. Over 50 volunteers completed 149 community member participations and 60 trained volunteer facilitations for the 105 cases conferenced. Along with the referred youth, 6 direct victims, 94 family members and 1 victim supporter met face-to-face with community members at the conferences.
