For 75 years, Perry Technical Institute has been putting people of all ages and walks of life to work in careers that provide family-supportable wages, benefits, and chances for advancement. The school serves the needs of a variety of industries by equipping students with strong technical skills and positive work habits. Faculty members with extensive experience in industry provide specialized classroom instruction and hands-on lab and shop experiences. Over 700 students are enrolled in Perry's 12 training programs. The school's retention rate is 84% and the placement rate is 90%. In 2016, Perry completed the reaccreditation process, resulting in full accreditation with no findings.

Perry Technical Institute completed a major expansion project during the 2015-2016 year. Plath Hall opened in December 2015 to house the instrumentation and industrial automation technology program. The facility brings a state of the art learning atmosphere to the more than 170 students in the program. Instrumentation is a two-year program that introduces students to today's world of computerized industrial automation. The program has a retention rate of 89% and a placement rate of 95%. Currently, the program is full until 2017. The addition of Plath Hall also allowed for the expansion of the electrical program. The program has gained 5,000 square feet of lab space to allow for new and enhanced training equipment for the 170 students in the program. Electrical Technology is a two-year program that trains students to install, connect, test, and maintain electrical systems in industrial, commercial, and residential settings. The program has an 88% retention rate and a 100% placement rate. Currently, the program is full until mid-2017. Finally, Plath Hall allowed for the addition of two new programs. The agriculture equipment technician program started in late June 2016 and Construction Technology is scheduled to begin in October 2016.

Perry Technical Institute's Instrumentation & Industrial Automation Technology Program has developed a reputation as one of the nation's premier programs for training instrumentation technicians. The two-year program introduces students to today's world of computerized industrial automation. Instrumentation technicians can use their skills anywhere in the world, in industries such as manufacturing, pharmaceuticals, refining, power generation, packaging, food processing, and pulp and paper production. The program has a high retention rate of 90%, a high placement rate of 94%, and graduates land high-paying jobs. Currently, the program is full until March 2016.
