Westside school implements state and national grade level standards within each classroom To effectively assist students' academic progress, the classroom teacher periodically assesses each child using a variety of formal and informal tools Results of these assessments are shared with the parents Parents have the right to engage a tutor of their choice, however Westside school has staff members who offer tutoring services through the school If the parents choose the "in-house tutoring" the family is contacted by the school and the school pays the tutor for the service
