ALMOST A THIRD OF CHERRY CREST PTA'S PROGRAM SERVICE FUNDS ARE ALLOCATED TO CURRICULUM ENHANCEMENT PROGRAMS. ALL CLASSES RECEIVE A MINIMUM OF 4-6 PROGRAMS THAT ARE TEACHER DIRECTED BASED ON THE CURRICULUM. PROGRAMS RANGE FROM SMALL IN-CLASS ACTIVITIES (E G , MAKING LIP BALM AS PART OF A SCIENCE UNIT) TO LARGER OFF-SITE FIELD TRIPS (E G , CAMP WASCOWITZ, MARINE SCIENCE Afloat). ADDITIONALLY, THE PTA FUNDS AN ANNUAL AUTHOR VISIT AT CHERRY CREST WHICH IS COORDINATED WITH A CROSS-SCHOOL LIBRARIAN COMMITTEE TO BRING SAME AUTHOR TO MULTIPLE SCHOOLS. THE ALL SCHOOL PASSPORT CLUB CONTINUES TO FOSTER KNOWLEDGE AND INTEREST IN THE WORLD BEYOND THE CHERRY CREST COMMUNITY. ANOTHER PROGRAM SERVICE PROVIDED BY THE PTA IS PROVIDING FUNDS FOR THE STAFF'S USE TOWARDS CLASSROOM SUPPLIES, CLASSROOM LITERATURE OR GAMES/MATERIALS TO COMPLEMENT THE CURRICULUM. TYPICALLY, THE LARGEST PROGRAM SERVICE EXPENDITURE IS FOR STAFF AIDES. CHERRY CREST PTA DONATED FUNDS TO SUPPORT THE AIDES.
