The Agros model is a uniquely holistic approach to alleviating rural poverty. By providing long-term land loans to the poor along with integrated services such as community organization, agriculture and health training and financial education, entire rural villages are empowered to become self-sustaining and escape the devastating effects of extreme poverty. Our program served 405 families living in 7 communities and 3 countries, with continued advancements in agriculture, health and well-being, financial empowerment and education. * The educational highlight this year was the construction of a new primary school in our Honduran community of Bella Vista. School attendance within Agros’ communities is 99%. * Over 50% of our community families participated in an accelerated economic plan that provides access to high-level finance, training and commercialization support. * As part of the final stage of our development model, called The Path to Prosperity, 110 of our community families paid off their land loans. * Agros sponsored service teams to Agros villages in which 141 U.S. individuals participated.
