	After-school Study Programs Allows struggling students to receive homework and one-on-one academic support. The goal is to help these learners become more fluent readers, more proficient in math, and most importantly, to stay on track toward graduation. 1,158 students attended after-school study support at all four comprehensive middle schools. Classroom & School-Wide Enrichment Grants Small, innovative classroom and school-wide grants that support teacher instruction and enhance classroom learning environments. 26 teachers received classroom grants and 31 principals received school-wide grants. Bridging the Digital Divide Bringing digital media to low-income students in their homes. Students will no longer scramble to find alternative resources to complete assignments, and are able to stay abreast of homework assignments. 1,100 refurbished laptops provided to students. PSAT/PLAN exams are offered to 3,000 junior students, and are conducted at all five comprehensive high schools. This eliminates cost, access and transportation barriers, and helps students to identify potential college pathways. 315 Junior's received stipends to take the PSAT exam. College in the High School Tuition is a program that allows students to take college-level courses while in high school, with a fee required to earn college credit. The Foundation provides scholarships or College in the High School tuition for students in financial need. 122 students received assistance. Smart Test Fees 194 students earned 625 world language credits in 31 different languages, and 30 students earned Washington State seal of biliteracy. Our programs are designed to give students the opportunity to achieve academic success throughout their K-12 school career, so that they will be prepared to lead productive lives and enter either post-secondary education or career fields, and most importantly so that ALL students will have hope for brighter futures!
