Outreach for intensive year-long and seasonal faith-based teacher trainings reached 645 participants. Faith-based experiential education reached over 800 participants. Faith-based business training/coaching reached over 400 participants. Approximately 20 volunteers, including seconded staff from other non-profit organizations, serve the organization.
