Academic Enrichment Phase - We successfully recruited our 15th Cohort of scholars this year, including students from Renton, Highline and Seattle School districts. Meanwhile, Cohort 13 completed their final summer in August 2015 with 100% earning placement into independent schools or highly-capable public school programs. Cohort 14 completed their school year in 2015-16 achieving a 98% placement rate in college preparatory settings with 40% in public school programs and 58% earning placement at independent schools.

College Support 95% of scholars have matriculated to college over the past seven years. In this most recent year, 170 college scholars were served through ongoing comprehensive support and outreach, 100% of freshmen received on site campus visits from Rainier Scholars staff. An essential College 101 retreat provided critical support for transition into college life. Internships and additional career networking opportunities were provided to build professional networks. We now have nearly 140 college graduates. 87% of our first three cohorts have graduated within five years. Rainier Scholars alumni are now employed throughout the region and the country at companies/institutions such as Amazon, Boeing, Cascadia Capital, Google, Liberty Mutual, Honeywell, Teach for America and Uncommon Schools. Other alums have been accepted to medical school or are enrolled in graduate school programs pursuing master degrees. As we look at the leaders and community members our scholars are evolving into, we feel humble confidence that our model, which begins at age 11, truly offers the opportunity for students who otherwise would not have access to the high quality college preparation and leadership development experiences, to become the young adults they want to be, and in so doing, become members who so greatly enrich our communities and our world.

Leadership Development - 116 scholars participated in leadership retreats with 85% demonstrating enhanced leadership skills and participation in leadership activities in school and community. To date we have successfully placed students (high school and college) in over 400 internship experiences with the majority receiving high marks by workplace mentors. Our eighth cohort of scholars achieved 100% high school graduation as well as 100% acceptance to four year colleges and universities. For the last seven years over 50% of every cohort matriculated to the Most/More selective colleges and universities across the nation.
