The Burke Museum Association raised \$286,000 through the annual fund and an additional \$416,000 through the Curators Dinner, the organization's annual gala. These funds made it possible for the Burke Museum to diversify its financial support. During the year the Museum served 106,000 schoolchildren, received over 110,000 on-site visitors and provided curation resources for 16 million objects. The BMA also provided partial support for research, exhibitions, and maintained the museum gift shop.
