THE TOTAL EXPENSES OF NORTHERN SOUTHEAST REGIONAL AQUACULTURE ASSOCIATION (NSRAA) ARE DIRECTED TOWARD PRODUCING SALMON FRY AND SMOLT AT THREE FACILITIES (MEDVEJIE, HIDDEN FALLS, & SAWMILL COVE HATCHERIES), ONE LAKE STOCKING PROGRAM AT DEER LAKE, AND SEVERAL SPAWNING CHANNELS IN THE HAINES AREA. THE PRODUCTION OF SALMON FRY AND SMOLT ARE ANNUALLY RELEASED TO THE OCEAN AND RETURN IN TWO TO FOUR YEARS TIME, DURING WHICH THE FISH ARE A PUBLIC RESOURCE AND BELONG TO THE CITIZENS OF THE STATE OF ALASKA. THE PURPOSE OF RAISING AND RELEASING SALMON IS TO INCREASE THE COMMON PROPERTY CATCH AND VALUE IN SALMON FISHERIES THROUGHOUT SOUTHEAST ALASKA. NSRAA PRODUCES AND RELEASES APPROXIMATELY 250 MILLION CHUM SALMON FRY, 7.5 MILLION COHO SMOLT, AND 3.4 MILLION CHINOOK SMOLT ANNUALLY.
