During fiscal year 2016 (July 1, 2015 through June 30, 2016), we provided 34,370 congregate meals to more than 1,000 individuals Home-Delivered Meals - Utilizing our transportation fleet, we delivered 56,227 nutritious meals to over 205 eligible homebound seniors and disabled adults during fiscal year 2016 Transportation - MSSS provides door-to-door transportation services for seniors and disabled adults providing access to medical facilities, senior centers, adult day services, etc. During fiscal year 2016, we provided 27,339 one-way rides to over 600 individuals totaling more than 265,000 vehicle miles in a vast geographical area covering approximately 2,500 square miles
