 Community of Cantwell, Inc -- Grant funds received from the Denali Borough for administration were distributed to the fire department and ambulance service via the fire department and ambulance checking accounts. (These grant funds are reimbursed funds -- CCI does not receive payment until the funds are spent--the fire service and ambulance service write checks for the expenses of their service and CCI is reimbursed by the grant funds.)
 The grant of \$1,200 helped purchase fuel to heat the Cantwell Community Center.
