THIS PROGRAM ALSO PROVIDES REFERRAL SERVICES TO THESE LICENSED PROGRAMS. IN FY16, AEYC SUPPORTED 450 CHILDCARE PROVIDERS IN SOUTHEAST ALASKA WITH 30 DIFFERENT TRAININGS FOR A TOTAL OF 1,010 TRAINING HOURS, 18 PROVIDERS WITH ASSISTANCE WITH OBTAINING THEIR CHILD DEVELOPMENT ASSOCIATE CREDENTIAL AND 26 PROVIDERS RECEIVING TECHNICAL ASSISTANCE. 35 PROVIDERS RECEIVED QUALITY IMPROVEMENT GRANTS TO ASSIST WITH PROGRAM EXCELLENCE. ALSO PROVIDED ON-SITE CONSULTATION TO 4 PROGRAMS TO IMPROVE THE QUALITY OF CARE. WE BEGAN A TARGETED PROGRAM OF RECRUITMENT FOR NEW CHILD CARE PROVIDERS INCLUDING EVENING OR NOON INFORMATIONAL MEETINGS, ATTENDANCE AT COMMUNITY EVENTS AND CITY ASSEMBLY COMMITTEE MEETINGS AND WORK WITH THE LOCAL ECONOMIC DEVELOPMENT COUNCIL ON REACHING BUSINESSES ABOUT JOB BASED CHILD CARE CENTERS. EARLY CHILDHOOD EDUCATORS ALSO RECEIVED PROFESSIONAL DEVELOPMENT ACTIVITIES IN THE FORM OF EDUCATIONAL INCENTIVES, WEB BASED ELEARNING MODULES AND A REGIONAL EARLY LEARNING CONFERENCE. WE AWARDED EDUCATIONAL WAGE INCENTIVES TO 25 PROVIDERS WHO HAD HIGHER EDUCATION CREDENTIALS. IN FY16 WE HAD 38 PARTICIPANTS ON THE ON-LINE TRAINING MODULES WE OFFER CALLED ABCD ELEARNING ON 4 DIFFERENT TOPIC AREAS. OUR ANNUAL SOUTHEAST EARLY LEARNING CONFERENCE WAS HELD THIS YEAR WITH OVER 200 PARTICIPANTS RECEIVING 20 HOURS OF TRAINING.
