THE HEALTH CENTER PROVIDED COMPREHENSIVE HEALTH CARE SERVICES TO INTERIOR ALASKA RESIDENTS. APPROXIMATELY 12,868 MEDICAL AND BEHAVIORAL HEALTH VISITS WERE PROVIDED. OF THE PATIENTS SERVED ACCORDING TO 2015 UDS DATA, 79% WERE LIVING AT OR BELOW 200% OF THE FEDERAL POVERTY GUIDELINES FOR ALASKA AND 8% WERE WITHOUT HEALTH INSURANCE. THE TOTAL UNDUPLICATED PATIENTS FOR MEDICAL AND BEHAVIORAL HEALTH SERVICES WERE 5,348. DURING THE YEAR, THE ORGANIZATION RECEIVED INKIND DONATIONS OF 16,197 FOR TELECOMMUNICATION SERVICES. THIS AMOUNT IS NOT INCLUDED IN PROGRAM SERVICE EXPENSES.
