NWRRC PROVIDES AN ESSENTIAL COMMUNITY RESOURCE BY HELPING INDIVIDUALS SUCCESSFULLY REINTEGRATE INTO SOCIETY FOLLOWING THEIR RELEASE FROM A FEDERAL CORRECTIONS FACILITY. NWRRC PROVIDES JOB PLACEMENT ASSISTANCE, CASE MANAGEMENT, COUNSELING, AND A SAFE AND DRUG FREE RESIDENTIAL ENVIRONMENT THROUGH CONTRACTS WITH THE FEDERAL BUREAU OF PRISONS AND U.S. PROBATION AND PRETRIAL SERVICES. WE SERVED APPROXIMATELY 465 PEOPLE DURING 2015-16. OF THOSE 465 IN OUR PROGRAM, WE HAD A TOTAL OF 421 RELEASES FROM THE PROGRAM. 310 OF THOSE RELEASES WERE DUE TO SUCCESSFUL COMPLETION OF OUR PROGRAM (73.6%) AND 111 WERE RETURNED TO CUSTODY (26.4% FAILURE RATE). THE NATIONAL AVERAGE RECIDIVISM (OR FAILURE) RATE IS APPROXIMATELY 30%. 83% OF RESIDENTS IN OUR PROGRAM WERE MALE AND 17% WERE FEMALE. THE AVERAGE AGE WAS 40.
