CITY OF PORTLAND OFFICE OF NEIGHBORHOOD INVOLVEMENT GRANT (ONI)SOUTHWEST NEIGHBORHOODS, INC (SWNI) PROVIDES CITIZEN PARTICIPATION SERVICES TO 17 MEMBER NEIGHBORHOOD ASSOCIATIONS (NA'S), AND TO SOUTHWEST PORTLAND RESIDENTS, SO RESIDENTS MAY EFFECTIVELY PARTICIPATE IN CIVIC AFFAIRS AND WORK TO IMPROVE THE LIVABILITY AND CHARACTER OF THEIR NEIGHBORHOODS AND THE CITY. OUR GOAL IS TO ENCOURAGE AND FACILITATE COMMUNICATION AMONGST COMMUNITY MEMBERS, NEIGHBORHOOD ASSOCIATIONS, AND PUBLIC AND PRIVATE AGENCIES AND GROUPS. ON DECEMBER 7, 2015 OUR EQUITY AND INCLUSION ACTION TEAM HELD A COMMUNITY CONVERSATION ON A DRAFT RACIAL EQUITY POLICY AND IMPLEMENTATION PLAN, WHICH PROMPTED CHANGES AND A DECISION TO BROADEN OUR OUTREACH EFFORTS OF THE POLICY, WHICH IS STILL UNDER REVIEW. OUR ANNUAL RETREAT IN APRIL, 2016 INCLUDED DISCUSSING NEXT STEPS FOR EQUITY AND INCLUSION AT EVERY LEVEL OF SWNI, ORGANIZATIONAL COMMITTEE TRANSACTIONS, LAUNCHING A WATERSHED COMMITTEE, AND PROVIDING INPUT INTO SWNI STANDING COMMITTEE ACTION PLANS. IN JUNE 2016, THE ORGANIZATION ESTABLISHED THE WATERSHED COMMITTEE AS A SPECIAL COMMITTEE, PLUS TRANSITIONED THE SWNI EQUITY AND INCLUSION ACTION TEAM AND OUR ORGANIZATIONAL COMMUNICATIONS COMMITTEE INTO STANDING COMMITTEES. THE GOAL IS TO HAVE REPRESENTATION ON THE STANDING COMMITTEES FROM ALL 17 MEMBER NEIGHBORHOOD ASSOCIATIONS (SEE NEW ORGANIZATIONAL CHART) DURING THE PAST YEAR. OUR ORGANIZATION SPONSORED A LEADERSHIP TRAINING FOR MEMBERS REGARDING "CONFLICT OF INTEREST", "CONFLICT OF LOYALTY", AND "CODE OF ETHICS". SWNI HOSTED MANY FREE COMMUNITY EVENTS INCLUDING COMMUNITY MEETINGS TO OPEN A TEMPORARY EMERGENCY SHELTER FOR HOMELESS, SW HOPE-AN EFFORT TO FEED THE HUNGRY IN SW PORTLAND, WATERSHED OPEN HOUSE, VOTER EDUCATION FORUM, AN EMERGENCY PREPAREDNESS FAIR, VOLUNTARY RECOGNITION EVENT, NEIGHBORHOOD MOVIES AND CONCERTS IN THE PARKS, MULTNOMAH DAYS STREET FAIR, NATIONAL NIGHT OUT EVENTS TO PROMOTE CRIME PREVENTION AND PUBLIC SAFETY, TRAFFIC VIGILS TO INCREASE DRIVER AWARENESS AND REDUCE ACCIDENTS, AND HOLIDAY COMMUNITY EVENTS. IN ADDITION, VOLUNTEERS PARTICIPATED ON SEVERAL CITY OF PORTLAND BUDGET ADVISORY COMMITTEES, PARK MASTER PLANNING EFFORTS, THE SOUTHWEST CORRIDOR PLAN, TRANSPORTATION PLANNING EFFORTS, AND PUBLIC HEARINGS REGARDING THE 2035 CITY OF PORTLAND COMPREHENSIVE PLAN AND EARLY IMPLEMENTATION PROJECTS. IN JULY, SWNI AND MEMBER NEIGHBORHOOD ASSOCIATIONS REACHED OUT TO EVERY HOUSEHOLD IN OUR AREA WITH MAILINGS OF OUR FREE MONTHLY NEWSPAPER AND SPECIAL POSTCARD INVITATIONS TO SUMMER NEIGHBORHOOD EVENTS. SOUTHWEST NEIGHBORHOODS, INC AWARDED \$11,287 IN NEIGHBORHOOD SMALL GRANTS TO NINE COMMUNITY PROJECTS. SEE ATTACHED DESCRIPTIONS.

IN ADDITION TO THE GRANT FROM BES, THE WRC RECEIVED PARTNERSHIP FUNDING THROUGH WEST MULTNOMAH SOIL AND CONSERVATION DISTRICT (WMSWCD) TO HIRE TEMPORARY, PART TIME STAFF TO SUPPORT PROGRAMS AND PROJECTS TO EDUCATE, INSPIRE, AND INCREASE CAPACITY FOR RESTORATION ON PUBLIC AND PRIVATE PROPERTY. STORMWATER WORKSHOPS WERE ORGANIZED TO EDUCATE RESIDENTS ON HOW TO REDUCE STORMWATER RUNOFF, IMPROVE STREAM HEALTH, REDUCE FLOODING, AND LEARN LANDSCAPING OPTIONS.
