	Botany Horticulture-- We transformed the Encaceous and center circle plant beds. We began tree removals under the Programmatic Permit issued by Urban Forestry. With Portland Parks we collaborated and contributed to the plans for horticultural elements in the Upper Garden. Our summer lecture series focused on botanical/horticultural topics. Garden staff recruited new volunteer teams to do replanting of existing botanical collection areas. A second horticultural intern was selected to work in the garden during the summer. Partnerships continued with staff from OSU, Hoyt Arboretum and Wisdom of the Elders. We extended our hours in late summer to allow more people to visit.
