Clackamas Womens Services (CWS) operates and Emergency Shelter and Housing Program that includes a 24-hr support line and the Lethality Assessment Protocol (LAP) CWS operates the largest emergency shelter program for survivors of domestic and sexual violence in the State and the only housing program solely focused on serving survivors in the County Over the past several years, the confidential CWS emergency shelter has developed an innovative model designed to break the isolation of domestic violence by creating a community of women from many different backgrounds with a shared experience The Village Model provides a supportive environment where survivors can step away from their current home lives, regain their strength, and individually shape the ways they want to move forward in the world It is a place where participants are considered unconditionally as experts in their own self-determination

Clackamas Women's Services (CWS) opened A Safe Place Family Justice Center for Clackamas County in December 2013 through a partnership that includes Clackamas County Sheriffs Office, Clackamas County Board of County Commissioners, El Programma Hispano, Oregon Department of Human Services and many others Clackamas Women's Services provides 75% of the community based services offered at the Center Located on the Clackamas County Campus at Red Soils in Oregon City, A Safe Place brings law enforcement officials, legal service providers, victim advocates, and community providers together under one roof to help families escape and recover from domestic violence, sexual assault, sexual exploitation, trafficking, elder abuse and vulnerable adult abuse Clackamas Women's Services is headquartered at A Safe Place Family Justice Center and delivers the agency's community based services through this hub The agency's community based services include trauma informed services through rural outreach, counseling and support groups, legal advocacy, crisis intervention, co-located advocacy, economic empowerment, population specific support, Camp HOPE, and long-term wraparound support services The agency's volunteer program, youth violence prevention program, and community education program are also delivered through this model In addition to community based services, Clackamas Women's Services also provides a 24-hour crisis and support line, a 33 bed emergency shelter, and a housing program

Camp HOPE Oregon, sponsored by A Safe Place Family Justice Center for Clackamas County, is a new three-year pilot project serving children who have witnessed or experienced domestic and sexual violence The idea behind Camp HOPE is to help children heal from trauma and have the fun, playful experiences that they deserve Developed through the National Family Justice Center Alliance in 2003, and accredited with Camp HOPE America, Camp HOPE Oregon is based on proven research that indicates how important hope is for child survivors of violence It is a natural extension of the Family Justice Center model This past summer, we completed the second of three pilot years that Clackamas Women's Services will conduct for Camp HOPE Oregon Camp HOPE Oregon activities are hosted in Welches, Oregon Camp HOPE Oregon includes two week-long sessions of overnight camp One week is geared toward ages 6-10 and the other week toward ages 11-15 Camp HOPE activities are meant to help foster a sense of community, demonstrate positive role modeling, and provide children with fun, high-adventure experiences Camp HOPE Oregon is also a mentoring program that provides therapeutic and/or pro-social experiences for campers and their family members regularly throughout the year
