HOUSING AND SUPPORT - THE HOUSING AND SUPPORT SERVICES DEPARTMENT OFFERS ONE-ON-ONE SUPPORT IN FINDING AND MAINTAINING HOUSING, COORDINATES CASE MANAGEMENT INTAKE, OFFERS EDUCATIONAL PROGRAMS TO HELP PEOPLE LIVING WITH HIV THRIVE AT HOME AND AT WORK, BUILDS COMMUNITY AMONG THE HIV POSITIVE, AND STRENGTHENS FAMILIES. 718 HOUSEHOLDS RECEIVED RENT, UTILITY AND EMERGENCY ASSISTANCE, AND 2,385 HIV-POSITIVE PEOPLE RECEIVED SOME FORM OF SUPPORT SERVICES FOR THE YEAR ENDED JUNE 30, 2016. ASSISTANCE WITH HOUSING INCLUDES BOTH LONG-TERM AND SHORT-TERM OR EMERGENCY HOUSING ASSISTANCE AND HELP MOVING AND FINDING FURNISHINGS.
