	HEAT OREGON PARTNERED WITH LOCAL COMMUNITY AND SOCIAL SERVICE ORGANIZATIONS TO DELIVER ENERGY ASSISTANCE TO QUALIFYING HOUSEHOLDS. HEAT OREGON RAISES MONEY TO MAKE PAYMENTS DIRECTLY TO UTILITIES OR VENDORS ON BEHALF OF LOW-INCOME CUSTOMERS. HEAT OREGON ASSISTED APPROXIMATELY 1,783 HOUSEHOLDS, 4,711 INDIVIDUALS WHICH INCLUDES 1,620 CHILDREN, 2,549 ADULTS, AND 542 SENIORS. HEAT OREGON'S FUNDS WILL BE SPENT IN ACCORDANCE WITH THEIR FISCAL POLICY DETAILED IN SCHEDULE O. THIS POLICY HAS BEEN LARGELY APPLIED TO SPENDING OF RESTRICTED FUNDS DEDICATED TO ENERGY ASSISTANCE. DUE TO SUCCESSFUL FUNDRAISING EFFORTS, COLLECTION OF UNRESTRICTED FUNDS HAVE GROWN AND NOW EXCEED THE AMOUNT NEEDED FOR ADMINISTRATION AND FUNDRAISING. CONTINUING TO RESERVE UNRESTRICTED FUNDS FOR ADMINISTRATION AND FUNDRAISING WILL PRODUCE LOWER ENERGY ASSISTANCE FUNDING AND A GROWING ENDING BALANCE (NET ASSETS) INTO THE FORESEEABLE FUTURE. RECOGNIZING THAT DONORS EXPECT THEIR FUNDS TO BE USED AS MUCH AS POSSIBLE TO HELP PEOPLE IN NEED, THE RESULTS OF THE CURRENT YEAR ACTIVITY CAN BE FOUND ON THE FORM 990, LINE 19.
