The JPR Foundation (JPRF) is an Associate Foundation of Southern Oregon University (SOU) with its primary mission being to raise
funds and support SOU's regional public radio network, Jefferson Public Radio (JPR). JPR strives to extend SOU's regional
educational mission and commitment to life-long learning by providing public affairs and cultural programming designed to:
promote informed citizen participation toward creating responsive government; create and foster a climate which encourages
tolerance for the expression of diverse viewpoints; and support and encourage the arts. In addition to raising funds, the JPR
Foundation publishes The Jefferson Journal, a magazine disseminated to JPRF contributors to provide public information about
JPR's service; operates an on-line civic network called JEFFNET to support JPR's on-line services; and assists in the management
and operation of radio communication sites on which JPR operates some of its stations. JPR is a member of National Public Radio,
the Corporation for Public Broadcasting, the Northwest Public Affairs Network, Western States Public Radio and an affiliate of
Public Radio International and American Public Media.

healthier communities, (2) foster the development of community appreciation for the dramatic, cinematic and musical arts by

the historic resources and character of communities by acquiring and restoring architecturally significant properties in a manner
