Nature of operations and program service accomplishments

New Hope Christian College (the College) is a private, four year Christian College locating in Eugene, Oregon. The College offers degrees in four areas of emphasis: theology, ministry leadership, creative arts and general education. The College also provided room and board facilities to students.

Significant Accomplishments:

This year's gala fundraiser featured A.J. Swoboda, an author of nine books, a church planter in Portland, Oregon and an alumnus of NHCC. A.J. described the arduous but fruitful work of planitng a church in one of America's gospel resistant cities. He closed his message by thanking New Hope Christian College/Eugene Bible College for giving him a strong foundation in ministry preparation. The Gala raised over \$ 52,000 for scholarships.

Every year the Association for Biblical Higher Education sponsors a national forum four outstanding students. This year two of our students were asked to present papers at the forum, Simon Arnold and Jacob Thiessen made presentations that were well received and will be included in a professional journal. In October 2015, we launched our cohort in our new Master of Arts in Christian Ministry degree.

The degree is designed to help church leaders develop greater skills in leading churches to reach their communities for Christ. The program is led by Dr. Jim Beaird, Regional Executive Director for the Southeast Region. Since the program is online, Open Bible students from Florida, California, Oregon and Japan currently participate. Natriana Shorter, a Business Administration major, was crowned Miss Oregon USA in November 2015. On June 5th 2016 she competed against fifty one other young women in the Miss USA pagent in Las Vegas. Natriana developed a program called "Triumph" which helps young people overcome peer pressure, low self esteem and encourages them to triumph above adversity. She is implementing this program in schools across the state by giving motivational talks to classes, youth groups and sports teams. Our athletic teams experienced new levels of success this year. Our women's basketball team did well enough in regular season to qualify for regional post season competition. We have our first track and field national champion Alicia Hatzel, a senion Christian Counseling student, won the javelin event at the NCCAA national championships in Rome, Georgia. They Harbick represented the College at ABHE national golf tournament for the second straight year. In the 2015-2016 academic year, sixty-seven students were given a total of \$ 54,400 from our endowed scholarships.
