The loan had an original principal balance of \$1,050,000, bears interest at 4.25%, and is payable in monthly installments of \$7,382 through December 2028. As of June 30, 2016, the principal balance outstanding on the loan is \$857,498. Pursuant to IRC 119(a)(2), an employee may exclude the value of housing provided by his/her employer if the requirements of that Section are met. Treas. Reg. 1.119-1(b)(3) indicates that lodging will be regarded as a condition of employment if the employee is required to accept the lodging in order for the employee to perform properly the duties of his/her employment. Lodging will be regarded as furnished in order for the employee to perform properly the duties of his/her employment when, for example, the lodging is furnished because the employee is required to be available for duty at all times. College Preparatory School does not have a night security service. If anything happened at the School at night (or during the day), the Head of School would have to be there to direct any response. Because part of the Head of School's job is to be available for these activities when and if they occur, it is the School's position that, in order to do his/her job, the Head of School must be available at all times. This meets the requirement for the exclusion of the value of the housing from taxable income. The approximate value of the nontaxable housing benefit received by the head of school is \$6,500 per month.
