A full program of services and partnerships is available, including continuing education, networking opportunities, access to consultants, and resources for fundraising. Fiscal sponsorship encourages funding agencies and contributors to take risks in financially supporting new projects and emerging artists, ensuring that money is well-managed and spent according to guidelines. Currently the Intersection Incubator provides support to more than 100 art projects and organizations across numerous disciplines and levels of experience, representing the extraordinary diversity of the San Francisco Bay Area cultural community.
