Home Visitation - Baby Steps Program HFA Home VisitationThe Healthy Families America (HFA) model provides the framework for our home visitation program, Baby Steps It is an evidence based, nationally recognized, home visitation program model designed to work with overburdened families who are at risk for child abuse and neglect and other childhood experiences It is a primary home visiting model designed to work with families who may have histones of trauma, intimate partner violence, and mental health and / or substance abuse issues Home visitation services are offered voluntarily, intensively, and over a long-term period of 3 -5 years Rigorous research has shown that HFA home visitation promotes parenting practices, improves family health, increases self-sufficiency (decreases dependency on welfare / social services), enhances school readiness, reduces child maltreatment and promotes overall child wellness Nationally, home visitation has been recognized as a "key strategy" to improving outcomes for children and families, as well as saving taxpayers over %40 billion dollars in remediation annually

Family Resource Services Each year at Cope Family Center more than 500 families seek a supportive, nurturing environment to help them deal with the stress of daily living Through our family resource center services, we use a strength-based, prevention focused approach to build parent's capabilities and prevent dysfunctional parenting practices Our comprehensive range of services meet each family's unique needs through peer support, crisis intervention, education, information and referral, and basic-needs services Triple P - Positive Parenting Program is the key curriculum used in our parent education program Triple P is the most extensively researched parent education program in the world Now in 25 countries, Triple P outcomes include, reduced problem behavior in children, improved parent well-being and parenting skills, lower rates of child abuse, reduced foster care placements, and a decrease in hospitalizations from childhood injuries Cope Family Center has embarked upon a collaborative, countywide implementation plan to offer Triple P to all parents in Napa County While Triple P is offered to all parents, we also provide fatherhood programming, using evidence informed curriculum and peer support groups, to assure the unique needs of fathers are addressed in all facets of service provision

Supervised visitation The supervised visitation program at Cope Family Center provides a safe venue for children and their parents to maintain, nurture and creat parent-child bonds during times of high family conflict These conflicts can include domestic volince, parental neglect, physical and emotional abuse, and drug or alcohol addiction Cope Family Center, in conjunction with the County of Napa, offers a protected, comfortable setting where children and their non-custodial parents are encouraged to interact and cultivate a child's emotional well being Supervised visitation maintains parent-child relationships necessary for successful family reunification while maintaining child safety Overall, supervised visitation has been shown to improve child support compliance, child behavior, performance in school and co-parenting skills We know that children, who have strong, positive connections to both biological parents fare far better than those who do not
