Wu Yee's Child Development program supports young children to reach their potential by offering full-day and year-round high-quality subsidized child care services to children aged 0-5. Our target population is low-income and recent immigrant families who are working in job training or in school and need child care. The program is designed to provide comprehensive child care services, to integrate parent involvement, education, physical health, mental health, nutrition, special needs and social services to the families that Wu Yee serves. Wu Yee served 455 children in thirteen child development centers located throughout the city of San Francisco, 30 children through the Family Child Care program, and 110 home-based.

Wu Yee's Child Care Subsidies Program assists eligible low-income families in San Francisco with child care case management, referrals and payments to child care providers. This is an essential program allowing parents to work or attend vocational trainings while their children are enrolled in a high quality child care program. Wu Yee's Child Care Subsidies Program served 591 children through the City Fund program.

Wu Yee's Child Care Provider Services Department provides training, technical assistance and stipends to child care providers in San Francisco in the various stages of their careers as well as improving quality through the Family Child Care Quality Network (FCCQN). Wu Yee's Provider Training programs partners with established family child care providers by training them on latest child development topics, so that they can maintain and achieve high quality practices in their field. The department also supports child care providers who are new to the child care field by assisting them through the application process of opening their own child care business and by providing them with child development trainings. The program also conducts site visits to child care microenterprises ensuring that high-quality and nutritious meals are being served through the Child Care Provider Food Program. We support 130 family child care micro-enterprises by providing reimbursements for qualifying meals/snacks. Additionally, we provide yearly training to provide proper and safe food handling, USDA food pyramid guidelines, ensuring good physical activity, and age appropriate meals and food options for children.
