Peninsula Open Space Trust (POST) protects and cares for open space, farms and parkland in and around Silicon Valley Since its founding in 1977, POST has saved more than 75,000 acres of permanently protected land in San Mateo, Santa Clara and Santa Cruz counties

As part of POST's work to address urgent conservation needs in and around Silicon Valley, POST protected a total of 313 new acres through the purchase of agncultural conservation easements during fiscal year 2016 We also transferred 308 acres to a public agency for permanent protection Finally, we protected 1 43 acres through fee title acquisition Project highlights are listed below In August 2015, POST purchased an affirmative agncultural conservation easement to permanently protect 13 acres from development and also guarantees the property will remain in agncultural production in perpetuity This property was once part of the historic Steele Ranch, a dairy operation that covered the Ano Nuevo Point area in the 1800's The property is now an educational farm teaching next generation farmers and local high school students how to be good stewards of the land through sustainable agnculture In October 2015, POST purchased another affirmative agncultural easement on a 300-acre property This picturesque farm has over 40 different organic crops, a majority of which feed local community members in need, in partnership with local charities The property has 250 acres of grassy hillsides used for grazing This easement protects the natural resources of this property which includes 19-acres of pnme wildlife habitat along the Tunitas Creek, potential home to endangered species such as the California red-legged frog In August 2015, POST transferred 308 acres of its previously acquired 318-acre Driscoll Orchards property in fee to the Midpeninsula Regional Open Space District The property is immediately off Highway 84 and includes a small apple orchard, cattle grazing, and the Driscoll Ranch event center The landscape contains a mix of low-lying oak forest, sloping grassland, coastal scrub, and a small but spectacular redwood grove In December 2015, POST acquired 1 43 acres in the southern Wavecrest area of Half Moon Bay The area is an accessible, signature coastal landscape The wetlands and coastal grasses at Wavecrest provide important habitat for wintering raptors as well as habitat for many other species including the California red-legged frog

POST currently holds 32,534 acres in fee or under easement The organization has an established stewardship program for the lands it owns that includes resource conservation planning and management, along with active uses of land for conservation grazing and agnculture where appropriate POST works to protect and manage lands in its possession through site-specific stewardship plans for the natural resources on each property POST staff and volunteers actively monitor the acreage on which POST holds easements or restrictions Volunteers also assist with stewardship projects on POST-owned land In total, POST stewardship volunteers contributed an impressive 1,400 hours of work time in 2015 POST also continues to play a leadership role as part of a working group of organizations and agencies addressing the threat posed by Hypencom canariense, a highly damaging and aggressive invasive exotic plant that is spreading along the San Mateo coast Other accomplishments include the following Rebuilt a decaying barn on Cloverdale Coastal Ranches to improve the long-term operation of Root Down Farm, a pasture based livestock operation on the property, and all future farms to come The new barn is built to last 300 years and uses both recycled wood from the old barn as well as locally grown redwood sustainably harvested from our San Vicente Redwoods property Continued sustainable timber harvest on 160 acres of San Vicente Redwoods The selective thinning helps to ensure long-term ecological benefits for a healthy forest Hired a Director of Conservation Science to ensure that POST is integrating the best available science and data into our work improving and caring for protected lands Drilled three wells in order to minimize use of stream water during peak usage seasons and provide farmers and ranchers with improved, more flexible water infrastructure Completed a long-term lease with an option to purchase on a scenic and productive 74-acre San Gregorio farm The lease keeps prime soil in production, while providing a popular organic farm with long-term stability and a place to connect with the community through seasonal programs and a roadside farm stand Supported efforts led by Midpeninsula Regional Open Space District for the creation of a conceptual design and feasibility study to provide safe passage for wildlife and improve regional trail connections across Highway 17

To further our community outreach and education efforts, in fiscal year 2016 the organization hosted five speakers chef, food writer, and co-producer of PBS food documentary television program Ruth Reichl, chef, restaurateur, and author Alice Walters, novelist, poet, and environmental activist Wendell Berry, writer and editor Mary Ellen Hannibal, and global water issues expert Jay Famiglietti POST also developed and mailed three issues of its donor magazine "Landscapes" to approximately 8,500 households The magazine reports on POST's land conservation and stewardship work throughout the year, as well as important news about conservation values that POST is working to maintain throughout the region Additionally, we sent out one POST electronic newsletter to just over 19,000 individuals each month of the fiscal year
