New Ways worked with the Public Policy Institute of New York - New York State P-TECH, CCCWDB Earn and Learn East Bay, Peralta Colleges-East Bay Career Pathway Trust, Contra Costa Community Colleges SB1070, and the Workforce Professionals Training Institute in NYC to build toolsets and materials to support high-quality work-based learning and employer engagement.
