THE LOS RIOS FOUNDATION AWARDED 471 SCHOLARSHIPS TO STUDENTS IN THE FOUR LOS RIOS COLLEGES, WHICH INCLUDE AMERICAN RIVER, COSUMNES RIVER, FOLSOM LAKE AND SACRAMENTO CITY. THESE SCHOLARSHIPS INCLUDED MONEY FOR DIRECT COST OF INSTRUCTION, TEXTBOOKS AND LIVING EXPENSES FOR STUDENTS WITH A HIGH LEVEL OF FINANCIAL NEED AND/OR OUTSTANDING ACADEMIC PERFORMANCE. THE SCHOLARSHIPS ARE FUNDED BY CONTRIBUTIONS RANGING FROM MODEST MONTHLY PAYROLL DEDUCTIONS FROM EMPLOYEES TO SIGNIFICANT CORPORATE OR PHILANTHROPIC GIFTS. MANY OF THE SCHOLARSHIPS ARE ACADEMIC PROGRAM SPECIFIC, OR TIED TO THE SPECIFIC INTERESTS OF AN INDIVIDUAL DONOR.
