We performed for 29,430 students and teachers and distributed to them 5,000 copies of our educational booklet. (The booklet also appears in its entirety, along with a recording of all the music from the opera, on our website at www.SierraChamberOpera.org.) The booklets were delivered to the schools in advance of the performance, to enhance the audience's understanding of the music and drama of opera. We issued a semi-annual newsletter which goes to 450 contributors and other interested people in the community. The public acceptance of our work increases, as do the understanding of our audiences and our contributions from individuals.
