During FY 2015-2016, El Pjaro CDC provided bilingual (English and Spanish) consulting, trainings and business incubation opportunities to underserved entrepreneurs, farmers and micro-businesses throughout Santa Cruz, Monterey and San Benito Counties Three hundred and forty five individuals received direct services and/or trainings Clients were assisted with costing, new business planning, marketing, loan packaging and other business related topics A variety of specialized trainings were provided trainings for family child care providers, food business entrepreneurs, start-ups, farmers and CalWORKs participants El Pjaro CDC continued to support Plaza Vigil Incubator tenants by providing them with over 450 hours of training, individual business coaching and leadership skills development During the fiscal year 2015-2016, El Pjaro CDC assisted 34 Small Business owners in preparing loan packages or to access other types of financials resources to start or expand their businesses Alternative sources included family investment, owner investment, and community lenders Of the clients assisted three have received over \$514,560 00 in capital infusion from banks and other lenders Many client loans are still in progress at the close of the fiscal year Because many of our clients have difficulties accessing loans, we are continually looking for alternative sources of financing For this reason, El Pjaro CDC continues to be a trustee for the Kiva Micro lending program This program provides 0% interest loans up to \$10,000 for small businesses and entrepreneurs who are financially excluded and underserved These loans are crowd-funded by individual lenders on the Kiva website, connecting entrepreneurs with dozens of lenders who can be potential brand ambassadors and customers to their business Our profile can be seen here https://www.kiva.org/trustees/1448BEI Pajaro CDCs newest program, The Commercial Kitchen Incubator (CKI) has been in serving Tri-County entrepreneurs for three years and currently has 38 small food businesses operating in the facility Three new clients are in the licensing process and four a using the kitchen on a seasonal basis El Pajaro CDC is proud of creating this community asset and loves to share the facility with the community by hosting events Hosting events like the first Event Watsonville, to the City of Watsonville Factory Sale events have drawn more 500 visitors to the facility Clients face several stumbling blocks in the process not the least of which is financing for their business venture For many this is their first venture into marketing and sales We encourage our producers to market themselves by participating in community events and the staff works hard to facilitate these opportunities In the past year clients have been featured at the Monterey Bay Birding Festival, The Corralitos Farm Tour, Pop-Up and Food Lounge in Santa Cruz, the Capitola Art and Wine Festival and the Fancy Food Show in San Francisco among others Acquiring county and state licensing has proven a challenge for others Through the experiences of our clients, we are learning and becoming more adept at streamlining the processes for future clients During the fiscal year ending June 2016, El Pajaro CDC was awarded a \$799K grant from The Department of Children and Families, Office of Community Services Community Economic Development Programs (CED) These funds are being used to support and expand the Kitchen Incubator Program including the construction of small batch co-packing line This co-packing service will serve as a second layer of incubation by allowing specialty food entrepreneurs and farmers in developing and producing value added products in larger quantities at a larger scale in a more cost efficient manner An important goal for this expansion is to create 40 full time jobs at the end of the grant period At least 75% of these positions should benefit low-income individuals
