PAN North America works to replace hazardous pesticides with ecologically sound, socially just alternatives. As one of five PAN Regional Centers worldwide, we link local and international consumer, labor, health, environment and agriculture groups into a citizens' network that challenges the global proliferation of pesticides, defends basic rights to health and environmental quality, and works to ensure the transition to a just and viable society.

Core programs: With partners across North America and globally, Pesticide Action Network mounts effective joint campaigns achieving bans and restrictions on highly hazard pesticides and promoting systemic, sustainable solutions for food security, food sovereignty, fair trade, worker protection and social justice. In particular, we advocate agroecology: farming in harmony with local environments that builds soil and resilient crops in the face of climate change, supplies healthy food and supports community health. In 2015–2016, our successes included: 1) getting better federal protections for farmworkers; 2) collaborating with farmers across Iowa to prevent pesticide drift; 3) expanding the Equitable Food Initiative among major retailers, growers and farmworker organizations to produce food certified to be safe for workers and consumers; 3) publishing a report on the latest science on children's exposure to pesticides and policies to better protect kids on the frontlines of farming; and 4) winning policies to protect honey bees in Minnesota and California.

4b (Code:) (Expenses \$ 623,139 including grants of \$ 0) (Revenue \$ 820,968)
Coalitions: PAN North America builds network power through strategic alliances with other public interest organizations. As the Regional Center of an international network, we facilitate collaboration among more than 150 organizations in North America, linked to some 600 groups in more than 90 countries worldwide. Often, our campaigns with network partners lead to creation of formal coalitions for which the Organization serves as facilitator, administrator and/or fiscal sponsor. The most significant coalition sponsored by PAN North America in 2015–2016 was Californians for Pesticide Reform (CPR—185 groups across the state, among which PAN is one of the leading members in policy advocacy for children's health and farmworker protection). In the last year CPR and PAN have worked with the State to promote sustainable alternatives to fumigants; protecting school children from pesticides applied to nearby fields; and promoting sustainable agriculture in the San Joaquin Valley. PAN also supported coalitions and advocacy networks in Colorado, Hawai'i, Iowa and Minnesota.
