In FY2016 we distributed 610,251 pounds of food to 15,343 households or 49,136 individuals. The food distributed is a combination of government commodities, purchased food and donated food from the Food Bank of Alaska, retail stores, individuals and religious organizations. In addition to our permanent location, we operate a Mobil Food Pantry once a week which distributed over 239,000 pounds of food to over 6,000 households.**4b** (Code:) (Expenses \$ 133,647 including grants of \$) (Revenue \$ 33,805)**EMERGENCY HOUSING SERVICES -**LSSA operates two HUD housing units. The first being the Transitional Living Program (TLP) that offers housing to single homeless men. The goal of the TLP is to break the cycle of homelessness and the residents find sustainable employment and thus sustainable housing. Clients are required to have a job in the first 30 days of residency and are required to be clean and sober. Clients are also required to participate in household chores and do volunteer work within the community. We served 20 men in FY2016.The second is a home for women with long term behavioral health issues. This unit provides safe and affordable housing for low income individuals with long term behavioral health and medical issues. In FY2016 we served 7 full-time residents.**4c** (Code:) (Expenses \$ 192,140 including grants of \$) (Revenue \$)**DIRECT ASSISTANCE -**LSSA's Direct Assistance Program covers three main areas. First is Neighbor to Neighbor, where we offer assistance to individuals who are looking for help obtaining a state ID, driver license, birth certificate, clothing vouchers, bus passes and prescription care. Second area is with assistance with homeless prevention or housing placement through help with rental or utility assistance or paying security deposits for housing and utility hookups. The third area is with transportation. We provide rides to and from medical appointments, and for those who have been medivaced into Anchorage we help with transportation back to rural Alaska. In FY2016 we assisted 1,458 individuals.**4d** Other program services (Describe in Schedule O.)
