Youth programs included: home-based tutoring, school-based programs, summer camps, family support/case management, family programming (community events, workshops, field trips), and community leadership opportunities. Of the high school seniors who received home-based tutoring in the last three academic school years, at least 88% graduated from high school (surpassing local graduation targets for English language learners).

Refugee Transitions is a community-based nonprofit agency serving high-need, low income refugee, asylee, and immigrant newcomers from over 50 countries. Based in the San Francisco Bay Area, RT provides education, family engagement, and community leadership programs that help newcomers become self-sufficient and successful in their new communities. Key components of our work over the last 30 years has been fostering cross-cultural relationships between receiving and newcomer communities, as well as multiplying newcomer students' capacity to help their own communities.

RT's vision is to see all newcomers thrive and become full, participating members of our shared communities. Our mission is to assist refugee, asylee, and immigrant newcomers in becoming self-sufficient in the U.S. by providing services that help them attain the English language, life, job, and academic skills they need to succeed in their new communities. We believe in the power of education to unlock opportunity, and we provide solutions that are transformative for students and volunteers alike. We believe that refugee, asylee, and immigrant newcomers have the resiliency and leadership potential to shape our world for the better.

RT's team consists of 12 staff members, 20-30 contract instructors; and a dedicated corps of approx. 250 volunteer tutors. Between July 1, 2015 and June 30, 2016, RT served 1,800+ unduplicated high-need, low-income refugee and immigrant newcomers with education, family engagement, and community leadership services. RT youth students' high school graduation and stay-in-school rates consistently surpass state, school, and school district rates for English learners. At least 95% of youth leaders go on to college. RT adult students meet or exceed California Department of Education goals for language level completion in 5 out of 6 levels. As for

self-sufficiency gains, 88% of our adult students tested pass life skills assessments that measure their ability to navigate systems in the U.S. After participating in RT classes, students self-report in surveys feeling more confident using English, more likely to be able to speak with teachers, and more likely to be able to read instructions to medication in English. In addition, they self-report being more likely to help other newcomers find community resources.
