The Perry Technical Foundation supports students attending Perry Technical Institute by providing a comprehensive scholarship program. Scholarships are offered twice a year to students in good standing who have completed one quarter or trimester. Applications are reviewed by a committee of independent volunteers and awarded based upon a student essay, grades, attendance, financial need and references. The Perry Technical Foundation distributed \$362,810 to 358 students in the form of scholarships during the 2015-2016 fiscal year.

The Perry Technical Foundation assists with educational programs at Perry Technical Institute through equipment purchases and capital improvements. During the 15-16 fiscal year, \$41,018 in equipment funds were disbursed. The equipment purchases help ensure that Perry Technical Institute students are receiving training on high quality equipment similar to what they will experience in industry. Capital funds support the growth of Perry Technical Institute. In 15-16 funds were raised to establish a new instrumentation and industrial automation facility on campus.

The Perry Technical Foundation supports students attending Perry Technical Institute by offering small loans to students. Loan funds are available to students with good credit who are struggling with the funds needed to purchase equipment or tools for their program. Loans are available on a first come, first serve basis to students who apply and pass the required credit check. Repayment begins six months after graduation. During the 15-16 fiscal year \$11,793 in loan funds were distributed.
