Provides mental health consultation, services to numerous preschool sites, helping teachers, administrators, and parents to effectively assist children and their families. The agency's early childhood staff has expertise in responding to children exposed to domestic and community violence, trauma and neglect. The agency also provides training to those providing mental health services to elementary, middle and high school students.

Home care for seniors - JFCS East Bay offers compassionate and reliable home-based attendant care services.

4c (Code _____) (Expenses \$ 1,083,193. including grants of \$ 461,152.) (Revenue \$ 113,444.)

Adult services - provides resources and support services to adults, older adults and their families. Services include geriatric consultation, care management, counseling support groups, educational workshops and a free Senior Information and Referral line. The agency also provides specialized services to Holocaust survivors. In addition, JFCS East Bay offers mental health and other supportive services to adults of all ages, including people with developmental disabilities and those who are dealing with bereavement.
