COASTAL HARVEST IS A WAREHOUSE DISTRIBUTION CENTER LOCATED IN HOQUIAM, WA. WE SOURCE AND DISTRIBUTE FOOD AND OTHER GOODS TO HUNGER RELIEF AGENCIES IN SEVEN SOUTHWEST WASHINGTON COUNTIES. THESE AGENCIES INCLUDE 52 FOOD PANTRIES, FEEDING PROGRAMS AND SENIOR CENTERS. OUR REACH ENCOMPASSES SIX NATIVE AMERICAN TRIBES AND OPERATES A MOBILE FOOD PANTRY IN TWO COMMUNITIES WITHOUT ACCESS TO HUNGER RELIEF PROGRAMS. COASTAL HARVEST ALSO CONTRIBUTES TOWARDS SEASONAL PROGRAMS, BACKPACK PROGRAMS AND SUMMER YOUTH PROGRAMS. IN ADDITION TO DISTRIBUTING FOOD, WE OPERATE A REPACK PROJECT. WE TRUCK IN FROZEN VEGETABLES FROM MULTIPLE SUPPLIERS FOR OUR VOLUNTEER REPACK PROGRAM. WE CONVERT LARGE BULK CONTAINERS INTO SMALL, FAMILY-SIZED PACKAGES FOR DISTRIBUTION. THIS PROJECT CONTRIBUTES HALF MILLION POUNDS OF FOOD EACH YEAR TO OUR AGENCY DISTRIBUTION.
