Started in 1997, College Track currently serves over 2,256 high school and college students in East Palo Alto, Oakland, San Francisco, New Orleans, Colorado, Los Angeles and Sacramento. Organization added Denver, CO as a location in this fiscal year. Over the last 20 years, more than 90 percent of seniors have been admitted to four-year colleges with 57% graduating in six or more years. 85% of our students are first generation college students.
