Organized into six different orchestras, arranged according to age, interest, and musical ability, the members rehearsed weekly and performed for the community in a variety of concerts. They gave 8 major concerts and 2 chamber music recitals during the regular season, conducted a summer music camp, and conducted an 8 day concert tour of Prague and Vienna.
