United Way of Santa Barbara County acts as a unifying and multiplying force We currently support over 30 partnerships focused on education, financial empowerment and health and twenty-two grants that involve over 200 organizations focused on leveraging the results of these partnerships United Way of Santa Barbara County produces results consistent with meeting its 2020 goals in education, financial empowerment, and health by using revenue from all sources, volunteer involvement, and advocacy for community improvement Some Education Examples - United for Literacy (UFL) is a county-wide initiative that was created through feedback from Santa Barbara community members about the extreme importance of education improvement UFL provides a multi-pronged set of services and partnerships designed to improve high school graduation rates - Born Learning, a part of United for Literacy, promotes awareness, education and action by providing new parents with resources, and information about utilizing every day moments as teachable moments - Dolly Parton Imagination Library (DPIL) is another component of UFL Provides brand new, AGE APPROPRIATE best practice books to families with children 0-5 years old These books are mailed free of charge every month from birth to Kindergarten, along with parent education, in order to provide resources for future educational success - TECHNOLOGY TOOLS & CUTTING EDGE TEACHER TECHNIQUES Reading Plus, another component of UFL, is a silent-reading online improvement program for 3rd graders through adults Using innovative technologies, students are able to improve reading comprehension, speed and vocabulary, and helps to detect problems with eye movement At the request of principals and teachers research was conducted to identify help for K-3 and very struggling readers, Lexia Reading was identified and tested With significant improvements in reading skills and scores, graduation rates will improve as well as students' self-esteem and attitudes toward academics - Stnde Academy is our current choice for online math intervention and improvement All these technology tools have been redesigned to be common core state standard compliant - Our Kindergarten Success Institutes (KSI) program completed its 17th year of operation This past year we delivered our KSI program to nine schools with 25 students per school Qualified students are 4 years old with no pre-school experience They are immersed into our four week intensive program where they learn letters, shapes, colors, numbers and appropriate kindergarten behaviors and confidence by the beginning of the school year - fun in the sun (FITS) The primary goal of the program is to reverse summer learning loss and eliminate our community's achievement gap between low-income students and their middle & upper income peers Fun In The Sun does this by using the best researched services and ideas from over 200 national public and private organizations and services In fact, Fun in the Sun was named 2012 National Award of Excellence in Summer learning Award Winner by the National Summer Learning Association/an affiliate of Johns Hopkins University Some Financial Stability Examples - Financial Stability Partnerships provide free tax assistance and financial literacy classes to low income families We have added financial literacy training for low income children and their parents through our "Fun In The Sun" program We also completed more than 3,100 tax returns and generated more than \$3,200,000 in refunds for poor families through partnerships with Santa Barbara High School, Housing Authority and others our Volunteer Income Tax Assistance (VITA) program has more than twenty community partners including five banks Outcomes based upon growth in bank account usage, retirement accounts, college/career planning accounts, budgeting usage, and other long-term financial asset building tools Some Health Examples - Health improvements include partnerships aimed at low cost prescription medicine, health services and children's health insurance THIS PAST YEAR, OVER 200,000 LOCAL FAMILIES RECEIVED IMPROVED HEALTH CARE SERVICES Some Volunteerism Examples - In September we had 1,300 volunteers collaborate to deliver \$350,000 worth of assistance to 49 charitable improvement activities throughout our community during our annual "Day of Caring" event We continued "www.volunteersb.org" an on-line volunteer matching service, to increase the quality and quantity of local volunteers with more than 20,000 visitors per year
